## Marine Act 1988 SECTION 15 NOTICE

I, Alan Osborne, the Director, Transport Safety, on the recommendation of Vincent Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 8.30 am to 5.00 pm Saturday 8 January 2011, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Wake Wars event and vessels owned and operated by Parks Victoria, is prohibited at the location detailed in Table 1.

### Victoria Harbour Exclusion Zone

The waters bounded by:

- (i) A line extending from a marker buoy located in approximate position 37° 49' 5.69118 S, 144° 56' 8.94552 E to a marker buoy in approximate position 37° 48' 56.852928 S, 144° 56' 32.17056 E;
- (ii) A line extending from a marker buoy located in approximate position 37° 48' 56.852928 S, 144° 56' 32.17056 E to a marker buoy in approximate position 37° 49' 0.328152 S, 144° 56' 28.44492 E;
- (iii) A line extending from a marker buoy located in approximate position 37° 49' 0.328152 S, 144° 56' 28.44492 E to a marker buoy in approximate position 37° 49' 7.438152 S, 144° 56' 10.01616 E;
- (iv) A line extending from a marker buoy located in approximate position 37° 49' 7.438152 S, 144° 56' 10.01616 E to a marker buoy located in approximate position 37° 49' 5.69118 S, 144° 56' 8.94552 E.

2. Vessels and vessel operators involved in the Wake Wars event, as approved by Parks Victoria staff, are excluded from the requirements of Clauses 2(a), 2(c) and 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
3. Vessels and vessel operators involved in the Wake Wars event, as approved by Parks Victoria staff, are excluded from the requirements of Clause 3(b) made under Schedule 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
4. At the completion of the event and/or as determined and announced by Parks Victoria, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
