## Road Safety Act 1986

### ROAD SAFETY (VEHICLES) REGULATIONS 2009

#### Specification of B-Double Routes

**1. Purpose**

The purpose of this notice is to specify a highway that is in an area and on a route that a B-double may travel in or on for the purposes of the Road Safety (Vehicles) Regulations 2009 (in this notice to be referred to as the Vehicles Regulations).

**2. Authorising provision**

This notice is made under regulation 187 of, and clause 11 of Schedule 8 to, the Vehicles Regulations. Clause 11 provides that a B-double may only be used on a highway that is in an area, or on a route, specified by the Roads Corporation by notice published in the Government Gazette or by a Class 2 permit.

**3. Commencement**

This notice comes into operation on the date it is published in the Government Gazette.

**4. Expiry**

This notice expires on 26 October 2016.

**5. Specification**

For the purposes of clause 11 of Schedule 8 to the Vehicles Regulations, I, Don Hogben, delegate of the Roads Corporation, specify the following as a B-double route –

- Chinamans Lane, Tungamah

**Note:** Words and phrases in this notice have the same meanings as in the **Road Safety Act 1986** and the Regulations under that Act.
