- 54/2011 (1) This Act comes into operation on a day to be proclaimed.
 (2) If this Act does not come into operation before 19 December 2011 it comes into operation on that day.
- 55/2011 (1) This Act comes into operation on the day after the day on which this Act receives the Royal Assent.
- 56/2011 (1) This Act (except section 3) comes into operation on the day after the day on which it receives the Royal Assent.
 (2) Section 3 comes into operation on a day to be proclaimed.
 (3) If section 3 does not come into operation before 31 December 2012, it comes into operation on that day.
- 57/2011 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
- 58/2011 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision referred to in subsection (1) does not come into operation before 31 December 2012, it comes into operation on that day.
