NOTICE OF SCHEDULE OF FEES AND COSTS FOR REFERRALS OF MEDICAL QUESTIONS TO THE MEDICAL PANELS

Pursuant to section 63(7) of the **Accident Compensation Act 1985**, I give notice of the following schedule of fees and costs (GST inclusive), fixed on the recommendation of the Convenor, for referrals of medical questions to the Medical Panels. This notice takes effect on 1 December 2011 and is effective until 30 November 2012.
