## Marine Act 1988

### SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vin Wright, Acting Regional Manager, Bays and Maritime Operations Parks Victoria (Waterway Manager for the Local Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

- (a) between the hours of 8.15 pm and 10.30 pm on Saturday 3 December 2011, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria is prohibited within 200 metres of a fireworks barge located in the approximate position 38° 08.630' S, 144° 22.322'E, GDA94 (approximately 200 metres east of the end of the Royal Geelong Yacht Club Marina);
- (b) at the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager, Bays and Maritime Operations, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 8.30 am to 5.00 pm on Saturday 4 December 2011, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the Docklands Cup Dragon Boat Festival, vessels owned and operated by Parks Victoria and vessels authorised by Parks Victoria, is prohibited on the waters of the Yarra River within the area detailed below in Table 1.

**Table 1: Victoria Harbour Exclusion Zone**

<p>The waters bounded by:</p> <ol style="list-style-type: none"> <li>(i) A line extending from a point 37° 49' 4.517328" S, 144° 56' 32.55144" E to a point 37° 49' 1.674408" S, 144° 56' 39.984" E;</li> <li>(ii) A line extending from a point 37° 49' 1.674408" S, 144° 56' 39.984" E to a point 37° 49' 3.717228" S, 144° 56' 41.3412" E;</li> <li>(iii) A line extending from a point 37° 49' 3.717228" S, 144° 56' 41.3412" E to a point 37° 49' 6.613752" S, 144° 56' 33.76608" E;</li> <li>(iv) A line extending from a point 37° 49' 6.613752" S, 144° 56' 33.76608" E to a point 37° 49' 4.517328" S, 144° 56' 32.55144" E.</li> </ol>

2. Vessels providing rescue services for the Docklands Cup Dragon Boat Festival are exempt from the 5 knot speed limit as detailed in clause 1 of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event.
3. Vessels providing rescue services for the Docklands Cup Dragon Boat Festival are excluded from the requirement to operate a vessel at a speed not exceeding 5 knots within 50 meters of a person in the water, another vessel, the waters edge and fixed or floating structures, as detailed clauses 2(a), 2(c) and 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event.
4. At the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
