- 74/2011      (1) This Act comes into operation on 1 February 2012.
- 75/2011      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
                  (2) If a provision of this Act does not come into operation before 1 July 2012, it comes into operation on that day.
- 76/2011      (1) This Act (except sections 10, 11, 15 and 17 and Part 3) comes into operation on the day after the day on which this Act receives the Royal Assent.  
                  (2) Sections 10 and 11 are taken to have come into operation on 1 April 2011.  
                  (3) Part 3 and section 17 come into operation on a day to be proclaimed.
- 77/2011      (1) This Act comes into operation on the day after the day on which this Act receives the Royal Assent.
- 78/2011      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
                  (2) If a provision of this Act does not come into operation before 1 October 2012, it comes into operation on that day.
