SECTION 15 NOTICE

I, Lisa Faldon, Deputy Director Waterway Safety as delegate of the Director, Transport Safety), on the recommendation of Darren Schultz, Building & Contracts Officer, Loddon Shire Council (Waterway Manager for Loddon River at Bridgewater between Flour Mill Weir and Sweeneys Lane), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 8.00 am Saturday 17 December 2011 to 8.00 pm Sunday 18 December 2011, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels and bathers associated with the Bridgewater Water Ski Tournament, is prohibited on the waters of Loddon River at Bridgewater between the Calder Highway bridge and Sweeneys Lane;
2. Vessels associated with the Bridgewater Water Ski Tournament on the Loddon River are excluded from the provisions clause 2 (5 knot speed restriction zones) of Schedule 62 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event;
3. At the completion of the event or at a time determined by Loddon Shire Council to enable the completion of the event, the waters will revert to the provisions of Schedule 62 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
