- 79/2011     (1) This Act comes into operation on a day or days to be proclaimed.  
80/2011     (1) This Part and Part 3 come into operation on the day after the day on which this Act receives the Royal Assent.  
              (2) The remaining provisions of this Act come into operation on a day or days to be proclaimed.  
81/2011     (1) Section 1, section 22(1), (2), (3) and (4) and this section come into operation on the day on which this Act receives the Royal Assent.  
              (2) Section 22(5) is taken to have come into operation on 12 October 2010.  
              (3) Section 22(6) is taken to have come into operation on 27 April 2010.  
              (4) Section 22(7) is taken to have come into operation on 21 June 2011.  
              (5) The remaining provisions of this Act come into operation on a day or days to be proclaimed.  
              (6) If a provision of this Act referred to in subsection (5) does not come into operation before 1 July 2012, it comes into operation on that day.  
82/2011     (1) This Act (except for section 8) comes into operation on the day after the day on which the Act receives the Royal Assent.  
              (2) Section 8 of this Act comes into operation on a day to be proclaimed which must be on or after the day specified by the Attorney-General in an order made under section 5.  
83/2011     (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
              (2) If a provision of this Act does not come into operation before 1 October 2012, it comes into operation on that day.
