- 71/2011      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation on 1 July 2012, it comes into operation on that day.
- 72/2011      (1) This Act comes into operation on a day or days to be proclaimed.
- 73/2011      (1) This Act (except Division 1 of Part 2 and Part 3) comes into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), Division 1 of Part 2 and Part 3 come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 October 2012, it comes into operation on that day.
