Marine Act 1988

SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Chris Hardman, Regional Manager – Melbourne Region, Parks Victoria (Waterway Manager for Albert Park Lake), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. The operation of vessels (including anchoring, mooring or allowing a vessel to lie), is prohibited on the waters of Albert Park Lake for the dates and times specified in Table 1.
2. Vessels listed in Table 2, Parks Victoria vessels and vessels approved by Parks Victoria are excluded from the prohibition on the operation of vessels for the times detailed in Table 1.
3. Vessels involved with the Australian Grand Prix Watershow are excluded from clauses 2(a), 2(c), 3(a), 3(b), 14, and 19(b) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the times listed in Table 1.
4. Skiers involved in the Water Ski Flag Line event are exempt from the requirements of Regulation 234(1) of the Marine Regulations 2009 and Clause 19(d) of Notice No. 1 under section 15(2) of the **Marine Act 1988**, for the times listed in Table 1.
5. When an approved non-commercially qualified person is operating a commercial vessel which is engaged in towing (as detailed in Table 2), the commercially qualified person must not act as an observer.
6. At the completion of events on any of the days detailed in Table 1 or at a time determined by Parks Victoria to enable the completion of events, the waters will revert to the provisions of Schedule 151 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
