FURTHER QUOTA ORDER FOR THE SCALLOP (OCEAN) FISHERY

I, Anthony Hurst, Executive Director Fisheries Victoria, as delegate of the Minister for Agriculture and Food Security and having undertaken consultation in accordance with section 3A of the **Fisheries Act 1995** (the Act), make the following Further Quota Order under section 64A(1) of the Act:

1. The 1 April 2011 until 31 March 2012 period is a 'quota period' for the purposes of this Order.
2. The total allowable catch for the Scallop (Ocean) Fishery during a quota period is zero (0) kilograms.

This Order commences on 1 April 2011 and expires on 31 March 2012.

FISHERIES (SCALLOP OCEAN FISHERY) (OPEN SEASON) NOTICE NO. 4/2011

1. **Title**
This Notice may be cited as the Fisheries (Scallop Ocean Fishery) (Open Season) Notice No. 4/2011.
2. **Objective**
The objective of this Notice is to fix a period during which the taking of scallops from Victorian waters is permitted.
3. **Authorising provision**
This Notice is made under sections 67 and 152 of the **Fisheries Act 1995**.
4. **Commencement**
This Notice comes into operation on 1 April 2011.
5. **Open Season**
The Scallop (Ocean) Fishery season commences on 1 April 2011 and ends on 31 March 2012 (both dates are inclusive).
6. **Revocation**
Unless sooner revoked, the Fisheries Notice will be automatically revoked on 31 March 2012.
