SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Steve Crawcour, Director Strategic and Community Development, Strathbogie Shire Council (Waterway Manager for the Waters of the Goulburn River from Hughes Creek to the Goulburn Weir including Lake Nagambie), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 6.30 am to 6.00 pm on 8, 9 and 10 April 2011, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved in the Melbourne Runabout & Speedboat Club Australian Championship and vessels operated by Strathbogie Shire Council, is prohibited on the waters of Lake Nagambie south and west of a line of buoys:
 - (a) from the waters edge at Willow Point opposite the Regatta Centre Public Boat Ramp;
 - (b) to the waters edge on the southern bank of the Lake adjacent to the 750 metre mark on the rowing course located in the exclusive use zone described in item 14 of Schedule 91 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
2. During the closure period above, competitors' vessels are prohibited from operating on the waters of Lake Nagambie and the Goulburn River, excluding the waters described above.
3. Vessels and vessel operators involved in the Melbourne Runabout & Speedboat Club Australian Championship are excluded from the requirements of item 14 of Schedule 91 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
4. Vessels and vessel operators involved in the Melbourne Runabout & Speedboat Club Australian Championship are excluded from the requirements of clauses 2(c) and 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
5. At the completion of the event or at a time determined by Strathbogie Shire Council to enable the completion of the event, the waters will revert to the provisions of Schedule 91 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. Between 7.30 pm and 10.00 pm on Saturday 23 April 2011, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Dromana 150th Celebration Fireworks display, is prohibited within a 200 metre radius of a fireworks barge located in approximate position 38°19'780"S 144°57'909"E (WGS84) approximately 200 metres east of the Dromana Pier.
2. At the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
