SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Inspector Stephen Guilmartin, OIC Water Police/Search and Rescue Squads of Victoria Water Police, hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. Vessels and operators listed in Table 1 involved with the 2011 Rip Curl Pro event, operating at Bells Beach (Torquay), Johanna Beach, ocean beaches from Portsea to Gunnamatta or Phillip Island surf breaks, between the hours of 7.00 am and 6.00 pm daily during the period from 16 April 2011 to 30 April 2011 are excluded from clauses 2(a), 2(c), 4(a), 18, 19(a) and 19(d) of Notice No. 1 made under section 15(2) of the **Marine Act 1988**.
2. The exemption in clause 1 above will be automatically suspended for any periods when swimmers or other vessels not associated with the event approach within 200 metres.
