Marine Act 1988

SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of David Jackson, Manager Land and On Water, Goulburn Murray Water (Waterway Manager for Lake Eppalock), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. Between 6.00 am and 5.00 pm on Sunday 1 May 2011, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Victorian Speed Boat Club Victorian Speedboat Championships and vessels operated by Goulburn Murray Water, is prohibited on the waters of Lake Eppalock in an area marked by buoys in the Derrinal Pool area in the vicinity of the VSBC leasehold;
2. Vessels engaged in the Victorian Speed Boat Club Victorian Speedboat Championships competition are excluded from the requirements of Clauses 2(c) and 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**; and
3. At the completion of the event or at a time determined by Goulburn Murray Water to enable the completion of the event, the waters will revert to the provisions of Schedule 49 contained in Notice No.1 made under subsection 15(2) of the **Marine Act 1988**.
