SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Yarra River), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 7.00 am Monday 16 May 2011 until 5.00 pm Saturday 18 June 2011, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie) is prohibited within 50 metres north from the edge of Central Pier commencing at the north-west end and extending 100 metres in a north-east direction and marked by lit special buoys, excluding vessels listed in Table 1 associated with salvage works to remove the Lady Chelmsford and Parks Victoria vessels.

Table 1: Excluded Vessels for Lady Chelmsford Salvage Works

2. At the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
