- 25/2011 (1) This Act comes into operation on 1 July 2011.
26/2011 (1) This Act (except for Part 3) comes into operation on the day after the day on which it receives the Royal Assent.
 (2) Part 3 comes into operation on 1 August 2011.
27/2011 (1) This Act, other than this section, sections 5, 6, 7 and 8, comes into operation on 30 June 2011.
 (2) This section comes into operation on the day that this Act receives the Royal Assent.

- (3) Section 7 is taken to have come into operation on 16 December 2009.
- (4) Section 8 is taken to have come into operation on 1 January 2010.
- (5) Sections 5 and 6 come into operation on 1 July 2012.
- 28/2011 (1) This Act (other than Divisions 1, 2 and 4 of Part 2, Division 2 of Part 3, Part 4 and Part 5) comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Part 5 comes into operation on 27 June 2011.
- (3) Divisions 1, 2 and 4 of Part 2, Division 2 of Part 3 and Part 4 come into operation on 1 July 2011.
- 29/2011 (1) Subject to subsection (2), this Act comes into operation on the day after the day on which it receives the Royal Assent.
- (2) The following items in Schedule 1 are taken to have come into operation on the following dates –
- (a) item 10.3 on 25 May 2009;
 - (b) item 17.2 on 28 September 2010;
 - (c) item 25 on 31 December 2009;
 - (d) item 43.1 on 20 October 2009;
 - (e) items 60.1 and 60.2 on 1 January 2010;
 - (f) item 75.3 on 31 December 2009;
 - (g) item 75.4 on 2 September 2008;
 - (h) items 86.2 and 86.3 on 10 August 2010;
 - (i) item 99 on 11 December 2007;
 - (j) item 100 on 21 May 2010.
