SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Yarra River Upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. For the times and dates detailed below in Table 1, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the City of Melbourne Winter Festival fireworks displays and those owned and operated by Parks Victoria, is prohibited on the waters of the Victoria Harbour within the area detailed below in Table 2.

1. For the times and dates detailed below in Table 1, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the Regional Arts Victoria Illuminated by Fire theatrical fireworks displays and those owned and operated by Parks Victoria, is prohibited on the waters of the Yarra River between the upstream edge of Federation Wharf and the Ships Prow (Birrarung Marr) as delineated by buoys.
