- 30/2011      (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
- 31/2011      (1) This Act (other than section 6) comes into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Section 6 is taken to have come into operation on 1 July 2010.
- 32/2011      (1) This Part comes into operation on the day on which this Act receives the Royal Assent.
- (2) Section 23 is taken to have come into operation on 30 June 2010.
- (3) Section 8 comes into operation on 1 July 2011.
- (4) Subject to subsection (5), sections 11, 13, 14, 15, 16, 17 and 22 come into operation on a day to be proclaimed.
- (5) If a provision referred to in subsection (4) does not come into operation before 1 February 2012, it comes into operation on that day.
- (6) Subject to subsection (7), section 12 comes into operation on a day to be proclaimed.
- (7) If section 12 does not come in operation before 1 July 2012, it comes into operation on that day.
- (8) The remaining provisions of this Act come into operation on the day after the day on which this Act receives the Royal Assent.
