Road Safety Act 1986

NOTICE UNDER SECTION 92(3)(HB)

Section 92 of the **Road Safety Act 1986** (the Act) regulates the use and disclosure of personal information held by the Roads Corporation.

Section 92(2) of the Act provides that it is an offence for the Roads Corporation or a delegate or employee of the Roads Corporation to use or disclose personal information except for certain specified purposes set out in section 92 of the Act.

Section 92(3)(hb) provides that it is not an offence for the Roads Corporation or a delegate or employee of the Roads Corporation to disclose personal information to a government department or agency of Victoria or any other State or a Territory or the Commonwealth that is specified by the Minister, by notice published in the Government Gazette, provided that the disclosure is for the purpose of assisting with the verification of information in a Victorian driver licence or learner permit issued, or purported to have been issued, under the Act in circumstances where that Victorian driver licence or learner permit is produced as evidence of identity to the specified government department or agency.

I, Terry Mulder, Minister for Roads, and Minister responsible for administering the Act, specify the government departments and agencies set out in the Schedule for the purposes of section 92(3)(hb) of the Act.
