The Minister for Planning has approved Amendment C182 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment inserts a new Incorporated Document titled '80 Collins Street Melbourne Development, June 2011' in the schedule to Clause 81.01 and also in the schedule to Clause 52.03 of the Melbourne Planning Scheme. The effect of the Incorporated Document will be to permit demolition, and the use and development of the land for the purpose of a mixed use development comprising Office, Retail premises and Residential hotel generally in accordance with endorsed plans.
