Aerodrome Landing Fees Act 2003

- 2. A fee per training flight approach (as defined under the Act) for a:

 - (b) rotary wing aircraft that touches the runway, of \$12.30 per 1,000 kilograms (pro-rata) of the aircraft's maximum take-off weight with a minimum charge per arrival of \$22.00; and
 - (c) fixed wing aircraft or a rotary wing aircraft that does not touch the runway, \$12.40.
- 3. A fee for parking of a:
 - (a) fixed wing aircraft with a maximum take-off weight (MTOW) under 3,000 kilograms, \$0.004 per kg/MTOW per day (or part thereof), with a minimum charge of \$12.00;
 - (b) fixed wing aircraft with an MTOW of 3,000 kilograms or more, of \$58.50 per day (or part thereof);
 - (c) rotary wing aircraft of \$58.50 per day (or part thereof);

- (d) aircraft outside aircraft parking clearance lines (including overhanging aircraft), an additional \$500.00 per day (or part thereof).
- (e) No parking fee is payable where an aircraft arrives at and then departs from Essendon Airport between 6 am and 5 pm on the same day, provided that the aircraft does not return to the airport until after 6 am the following day.
- (f) No parking fee is a payable where an aircraft is parked within a leased area of the airport.
- Aircraft not registered on the Australian Civil Aviation Safety Authorities Civil Aviation Register must, in addition to paying the above fees, pay a fee of \$40.40 per monthly invoice.

Where a fee is overdue by 60 days or more, an additional 10% will be added to the overdue amount.





At its meeting of 27 July 2011 the Greater Bendigo City Council resolved to adopt a new Streets and Roads Local Law No. 4 and the proposed amended provisions of the Administration Local Law No. 10.

The Streets and Roads Local Law has been developed with the following objectives:

- To control certain uses of streets and roads by persons, vehicles and animals.
- To control and regulate secondary activities on roads, including street parties and processions.
- Ensure that property numbers in the Municipal District are adequately marked and displayed.
- To regulate and control the construction of vehicle crossings to protect footpaths from damage.
- To regulate advertising signs on roads.

The table below identifies the key changes included within the new Streets and Roads Local Law.

Words Used in this Local Law	Introduces the words 'Council land', which is defined as land owned by, vested in or under the care, management and control of Council and includes roads, reserves and water courses.

Upon reading the material filed in support of this application, including the affidavit of Felicia Dean, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

 The applicant is an Aboriginal community controlled organisation, which was established in 1981. It has grown to

- become a leading Aboriginal organisation in Australia and the largest Co-operative outside metropolitan Melbourne. The applicant's philosophy is based upon self-determination and it has a self-management and governance structure. The managing board is comprised of seven members all of whom are Aboriginal and the Chief Executive Officer is Aboriginal. These positions have always been filled by Aboriginal persons.
- The applicant wishes to have the position of General Operations Manager filled by an Aboriginal or Torres Strait Islander person to ensure appropriate succession planning and to maintain the applicant's philosophy of self-determination and self-management.
- The applicant has been granted previous exemptions to fill positions with Aboriginal or Torres Strait Islander people for the same reasons as set out above (for example A49/2010, A101/2010 and A24/2011).
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equal and effective protection against discrimination of a non-Aboriginal or Torres Strait Islander person wishing to apply for the General Operations Manager position. I am satisfied that the exemption is a measure taken for the purpose of assisting or advancing Aboriginal and Torres Strait Islander people who are disadvantaged and so it does not amount to discrimination under the Charter. In any event, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

Upon reading the material filed in support of this application, including the affidavit of Susan Reid, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The object of the applicant is to maintain a women's health service that is community based and run by women for women, thereby creating an environment that is accessible, non-threatening and comfortable, where confidentially and respect for the women's perspective is attributed the highest priority.
- On 22 September 2008, the applicant was granted an exemption allowing it to advertise for and employ women only (A225/2008). That exemption remains in force until 1 September 2011. Accordingly, in so far as the applicant seeks to employ only a woman as the Closing the Gap Young Women's Health Project Officer (Project Officer), no further exemption is required.
- As to the application to employ only an Aboriginal or Torres Strait woman as the Project Officer, I have noted that a focus of the role is to assist in the execution of the Hume Regional Closing the Gap in Aboriginal Health Implementation Plan. The Project Officer will also play a role in building relationships to increase utilisation of mainstream health services by Aboriginal people. A particular responsibility will be increasing the health knowledge of Aboriginal and Torres Strait Islander adolescents and their networks and providing them with

information about sexuality and sexually transmitted infections. The Project Officer will also be expected to develop health education resources to support parents and carers. This work will clearly assist those Aboriginal and Torres Strait Islander young women and, if the Project Officer is an Aboriginal or Torres Strait Islander, she will have a greater capacity to relate to her clients and establish credibility in their eyes. This is known to increase engagement with services.

- Further, through employing an Aboriginal or Torres Strait Islander person, workforce participation of that part of the community will be improved. Statistics show that Aboriginal and Torres Strait Islanders have lower rates of workforce participation than those of the wider community.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equal and effective protection against discrimination of non-Aboriginal and Torres Strait Islander persons who would wish to be employed in the Project Officer role. I am satisfied that the exemption is a measure taken for the purpose of assisting or advancing Aboriginal and Torres Strait Islander people who are disadvantaged and so it does not amount to discrimination under the Charter. In any event, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 13, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.







ORDER DECLARING RESTRICTED AREAS IN NORTHERN VICTORIA FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Peter Walsh, Minister for Agriculture and Food Security, make the following Order: Dated 30 July 2011

Minister for Agriculture and Food Security

1 Objective

The objective of this Order is to declare restricted areas for the control of Queensland Fruit Fly in Northern Victoria, and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

2 Authorising Provision

This Order is made under section 20 of the **Plant Health and Plant Products Act 1995** (the Act).

3 Revocation

The Order made on 16 August 2010 under section 20 of the Act, and published in Government Gazette G33 on 19 August 2010, is revoked.

4 Definitions

In this Order -

'accreditation program' means any program under which a person is permitted to issue an assurance certificate, including any procedures available under the Interstate Certification Assurance (ICA) Scheme;

'authorised person' means a person authorised by the Department of Primary Industries;

'inspector' means a person authorised as an inspector under the Act:

'Manager Plant Standards' means the person for the time being occupying or acting in the position of Manager Plant Standards in the Department of Primary Industries;

'Queensland Fruit Fly' means the exotic pest *Bactrocera tryoni* (Froggatt);

'Queensland Fruit Fly host produce' means any fruit or vegetable, or plant in fruit listed in Schedule 1;

'Queensland Fruit Fly host material' means any Queensland Fruit Fly host produce or used packaging; and

'used packaging' means any packaging that has contained Queensland Fruit Fly host produce.

5 Restricted areas for the control of Queensland Fruit Fly

The restricted area for the control of Queensland Fruit Fly, known as the Greater Sunraysia Pest Free Area (PFA), is declared to be the area described in Schedule 2.

The restricted area for the control of Queensland Fruit Fly, known as the Fruit Fly Exclusion Zone (FFEZ), is declared to be the area described in Schedule 3.

6 Prohibitions, restrictions and requirements

- (1) The movement into the PFA of any Queensland Fruit Fly host material is prohibited.
- (2) Sub-clause (1) does not apply if the Queensland Fruit Fly host material:
 - (a) is accompanied by a plant health certificate issued by an inspector certifying that the material has been treated in a manner approved by the Manager Plant Standards; or
 - (b) is packed, labelled and certified in accordance with any conditions prescribed by an accreditation program under which the material is certified; or

- (c) is accompanied by a plant health declaration issued by an authorised person declaring that the material has been treated in a manner approved by the Manager Plant Standards; or
- (d) is consigned in any other manner approved by the Manager Plant Standards.
- (3) The movement into the FFEZ of any Queensland Fruit Fly host material is prohibited.
- (4) Sub-clause (3) does not apply if the Queensland Fruit Fly host material:
 - (a) was grown and packed, or last used, in an area of Victoria covered by an area freedom certificate issued by the Manager Plant Standards declaring that the area is known to be free from Queensland Fruit Fly; or
 - (b) is accompanied by a plant health certificate issued by an inspector certifying that the material has been treated in a manner approved by the Manager Plant Standards; or
 - (c) is packed, labelled and certified in accordance with any conditions prescribed by an accreditation program under which the material is certified; or
 - (d) is accompanied by a plant health declaration issued by an authorised person declaring that the material has been treated in a manner approved by the Manager Plant Standards.
- (5) Owners and occupiers of land described in Schedule 2 must, on written instruction from an inspector, and in a manner approved by the Manager Plant Standards, take action to control Queensland Fruit Fly, including stripping Queensland Fruit Fly host produce from plants, and treating or destroying plants.

7 Verification of Consignments

- (1) Any Queensland Fruit Fly host material imported into a restricted area in accordance with clause 6(2) or clause 6(4), and accompanying certificate or declaration must be:
 - (a) presented to an inspector for inspection; or
 - (b) verified by a person accredited to do so by the Department of Primary Industries.

Marine Safety Regulations 2011

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Marine Safety Regulations 2011

The proposed Regulations are made under Part 8.10 and section 315 of the new **Marine Safety Act 2010** (the Act), which will commence operation on or before 1 July 2012. The Act largely replaces the **Marine Act 1988**.

The objective of the proposed Regulations is to provide for safe marine operations in Victoria including in relation to –

- the registration and operation of vessels;
- licensing and endorsements on marine licences;
- certification of commercial and hire and drive vessels;
- various other matters to be prescribed for the purposes of the Act.

The RIS assesses the costs and benefits of the proposed Regulations and possible alternative means of achieving the stated objectives and explains why the proposed Regulations are the preferred option. The RIS concludes that the benefits of the proposed Regulations outweigh the expected costs.

1. Purpose

Notice Declaring Certain Motor Vehicles to be Probationary Prohibited Motor Vehicles

1. Purpose

The purpose of this notice is to declare certain motor vehicles are probationary prohibited motor vehicles.

2. Authorising Provisions

This notice is made under Regulation 56(4)(a) of the Road Safety (Drivers) Regulations 2009 which provides that the Roads Corporation, by notice published in the Government Gazette may declare that a vehicle or class of vehicle is a probationary prohibited vehicle.

3. Commencement

This notice comes into operation on 21 July 2011.

4. Revocation

The notice published in the Government Gazette No. S 518 on 30 December 2010 declaring certain motor vehicles to be probationary prohibited vehicles is revoked.

5. Notice

This notice expires on 31 August 2013.

6. Declaration

For the purposes of regulation 56(4)(a) of the Road Safety (Drivers) Regulations 2009, I, Don Hogben, Director – Vehicle Management and Safety, delegate of the Roads Corporation, declare that the following types of vehicles set out in the table below are probationary prohibited vehicles.



ORDER DECLARING CONTROL AREAS IN VICTORIA FOR THE PURPOSE OF PREVENTING THE ENTRY OF THE PEST GRAPE PHYLLOXERA

Order in Council

The Governor in Council under section 9 of the Plant Health and Plant Products Act 1995 –

- (a) revokes the Order declaring control areas in Victoria for the purpose of preventing the entry of the pest Grape Phylloxera (*Daktulosphaira vitifolii* Fitch), made under section 9 of the Act on 25 January 2011 and published in Government Gazette G4 on 27 January 2011. and
- (b) declares the areas described in the following Schedules to be control areas for the purpose of preventing the entry of the pest Grape Phylloxera from other parts of Victoria
 - Schedule 1 to be a control area to be known as the Western Phylloxera Exclusion Zone; and
 - (ii)) Schedule 2 to be a control area to be known as the Greater Geelong Phylloxera Control Area; and
 - (iii) Schedule 3 to be a control area to be known as the Northern Phylloxera Control Area; and
 - (iv) Schedule 4 to be a control area to be known as the Ballarat Macedon Sunbury Phylloxera Control Area; and
- (c) specifies the prohibitions in Schedule 5 which are to operate in the control areas to prevent the entry of the pest Grape Phylloxera from other parts of Victoria.

This Order shall come into effect on the day of its publication in the Government Gazette, and shall remain in operation for 12 months.

SCHEDULE 5

1. Definitions

In this Schedule -

'host material' means any plant, plant part or plant product of the genus *Vitis*, including potted vines, cuttings, rootlings, grapes, grape marc, grape must, juice, germplasm and plant and soil samples for diagnostic purposes;

'juice' means fresh, unclarified or unfiltered juice, but not juice filtered or otherwise processed so as to achieve a maximum particle size of 50 microns.

2. Prohibitions in the control areas

- (1) The entry into the control areas of
 - (a) any host material; or
 - (b) any agricultural equipment that has been used for the cultivation, harvesting, handling, transport or processing of plants, plant parts or plant products of the genus *Vitis*; or
 - (c) any package which has contained any plant, plant part or plant product of the genus *Vitis*: or
 - (d) soil originating from a property involved in the cultivation or handling of plants, plant parts or plant products of the genus *Vitis* –

is prohibited.

- (2) Subclause (1) does not apply in the case of any
 - (a) host material, equipment, package or soil sourced from, or last used on, a property located in an area of Victoria declared as a control area for preventing the entry of phylloxera; or
 - (b) table grapes treated in a manner approved by the Manager Plant Standards.

Note: Section 9(3) of the **Plant Health and Plant Products Act 1995** provides that a person is guilty of an offence and liable for a penalty not exceeding 100 penalty units for entering a control area contrary to any prohibition or restriction, unless authorised to do so under a permit issued by the Secretary.
