SCHEDULE TO THE ORDER IN COUNCIL

- 1. Appointment Arrangements**
The appointment is part-time.
- 2. Period of Appointment**
The appointment is extended for a period of six months from 18 August 2011 until 17 February 2012.
- 3. Duties and responsibilities of the position**
Under section 102(4)(a) of the **Disability Act 2006** ('Act'), the administrator is deemed to be the committee of management or other governing body of the disability service provider to the extent that the Minister considers necessary for the purpose of performing functions under the Act or under a contract or agreement under the Act.
- 4. Termination Arrangements**
Under section 102(10) of the Act, the Governor in Council, by Order in Council published in the Government Gazette, may declare the committee of management or other governing body is re-instated or, if its members ceased to hold office, is to be re-established by appointment or election as the case may be, and that the administrator ceases to be the administrator.
- 5. Payment Provisions**
The administrator will be paid \$218,400 per annum (inclusive of goods and services tax, superannuation, and travel costs) on a pro rata basis.
- 6. Superannuation Obligations**
The remuneration amount specified in item 5 above is inclusive of superannuation.
- 7. Travel and Personal Expenses arrangements**
The remuneration amount specified in item 5 is inclusive of travel and personal expenses of the administrator.
- 8. Leave Arrangements**
There are no leave provisions for this position.
- 9. Prior Service**
Not applicable.
