VICTORIA PLANNING PROVISIONS  
Notice of Approval of Amendment  
Amendment VC82

The Minister for Planning has approved Amendment VC82 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by amending:

- Clause 19.01 of the State Planning Policy Framework to reference the updated 'Policy and planning guidelines for development of wind energy facilities in Victoria (August 2011)'.
- Clause 36.03 – Public Conservation and Resources Zone to clarify the condition that relates to land described in the **National Parks Act 1975**.
- Clause 37.07 – Urban Growth Zone to prohibit a Wind energy facility on land in that zone.
- Clause 52.32 – Wind energy facility to:
  - include an additional application requirement for evidence of written consent of the owner of the dwelling located within two kilometres of a proposed turbine that forms part of the wind energy facility
  - identify locations where a Wind energy facility is prohibited
  - permit the use and development of an anemometer for more than three years
  - reference the updated 'Policy and planning guidelines for development of wind energy facilities in Victoria (August 2011)'
  - insert a new schedule to Clause 52.32 – Wind energy facility for 30 Planning Schemes that specifies where a wind energy facility is prohibited.
- Clause 81.01 removes the 'Policy and planning guidelines for development of wind energy facilities in Victoria, March 2011' from the list of incorporated documents.
