SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vin Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Local Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that the following amendments be made to Notice No. 1 under section 15(2) of the **Marine Act 1988**:

1. The rules regulating the operation of vessels on the Waters – The Local Port of Port Phillip set out in Schedule 1 of Notice No. 1 under section 15(2) of the **Marine Act 1988** are hereby amended as follows:
 - (a) Clause 6(a)(v), in relation to the area prohibited to personal water craft at Werribee South, is deleted and amended to read 'Revoked';
 - (b) Clause 7(c)(i), in relation to the Exclusive Use area for personal water craft at Werribee South, is deleted and amended to read 'Revoked'; and
 - (c) Clause 1(b), in relation to the excluded speed limit for the personal water craft zone, is deleted and amended to read 'Revoked'.
