SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director Transport Safety), on the recommendation of Inspector Stephen Guilmartin, OIC Water Police/Search & Rescue Squads of Victoria Water Police, hereby give notice under section 15(2) of the **Marine Act 1988**, that the following amendments be made to Notice No. 1 under section 15(2) of the **Marine Act 1988**.

1. After Clause 25 of Notice No. 1 in the Index to Schedules:
after 'South Barwon (adjacent waters), State Waters, Schedule 11' and before Spoonbill Lake, Melbourne Water, Schedule 122, insert under the heading 'Waters' the words 'Bass Strait South Gippsland', under the heading 'Name of Authority' the words 'State Waters', and under the heading 'Sch' the number '2'.
2. After Schedule 1 insert Schedule 2.

SCHEDULE 2

WATERS – BASS STRAIT–SOUTH GIPPSLAND

Waterway Manager – State Waters

1. Prohibition of specific activities for the purposes of Clause 12.
Vessels are prohibited from anchoring in the waters within a 150 metre radius from the mid point of an outfall pipeline located: 38° 45.677' S, 145° 50.919' E (WGS84).
