                  (2) If a provision of this Act does not come into operation before 1 June 2012, it comes into operation on that day.
- 49/2011      (1) This Act comes into operation on a day or days to be proclaimed.  
                  (2) If a provision of this Act does not come into operation before 1 September 2012, it comes into operation on that day.
