42/2011     (1) Subject to subsection (2), this Act comes into operation on a day to be proclaimed.  
              (2) If this Act does not come into operation before 1 July 2012, it comes into operation on that day.  
43/2011     (1) This Act comes into operation on a day or days to be proclaimed.  
              (2) If a provision of this Act does not come into operation before 1 July 2012, it comes into operation on that day.  
44/2011     (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
              (2) If a provision referred to in subsection (1) does not come into operation before 1 January 2012, it comes into operation on that day.
