


Discontinuance of Portions of Road Reserves


Part of Howard Street between Victoria Street and Rosslyn Street, West Melbourne




Part of Curzon Street and part of Miller Street, West Melbourne





Protection of Public Assets and Control of Building Sites Local Law No. 11

At its meeting of 30 November 2011, the Greater Bendigo City Council resolved to renew the Protection of Public Assets and Control of Building Sites Local Law No. 11 for a 12 month period whilst completing a consultation process and review to replace the Local Law.

The purpose of the Protection of Public Assets and Control of Building Sites Local Law is to minimise the environmental and amenity impact from building sites. It also aims to protect public infrastructure from damage that may result from buildings construction activity.

The objectives of the Local Law are:

- 1. providing for the peace, order and good Government of the Municipal District;
- 2. protecting public assets vested in Council from damage, accelerated deterioration or abuse during the building process;
- 3. providing a physical environment which aims to minimise hazards to health and safety of persons attending building sites and those adjacent, opposite or passing building sites;
- 4. prohibiting, regulating and controlling the presence and disposal of refuse, rubbish and soil on and from building sites within the municipal district to reduce hazards to the environment and promote an environment where residents can enjoy a quality of life that meets the general expectation of the community;
- 5. defining the standards to which persons engaged in building work should adhere; and
- 6. educating and inducing persons involved in building work to act responsibly to reduce the extent and cost of infrastructure damage for the benefit of the wider community.

General (Amendment) Local Law 2011 No. 18

Notice is given pursuant to section 119(3) of the **Local Government Act 1989** that Frankston City Council, at its meeting held on 16 January 2012, resolved to make General (Amendment) Local Law 2011 No. 18.

Purpose of the Local Law

The purpose of the Local Law is to:

- introduce into Council's General Local Law 2003 No. 7 new measures regarding dangerous and unsightly land and nuisances and dilapidated buildings;
- revise penalties in respect of infringement notices issued under the General Local Law and penalties for offences under the General Local Law.

General Purport of the Local Law

The Local Law provides:

- (i) that an owner or occupier of land must ensure that the land or any structure on the land does not constitute a danger to health or property, is not unsightly, is kept free of graffiti and is not used in a manner that may cause a nuisance or become detrimental to the amenity of the immediate area:
- (ii) that an owner or occupier of land must not permit a building located on the land to become dilapidated or become further dilapidated;
- (iii) new penalties in respect of infringement notices for offences under Council's General Local Law 2003 No. 7 in respect of dangerous and unsightly land and nuisances and dilapidated buildings, including differential penalties for a natural person and a body corporate; and
- (iv) new penalties for offences under Council's General Local Law 2003 No. 7, including differential penalties for a natural person or body corporate in respect of offences relating to dangerous and unsightly land and nuisances and dilapidated buildings.



STONNINGTON PLANNING SCHEME

Notice of Preparation of Amendment

Amendment C154

Authorisation A02139

Stonnington City Council has prepared Amendment C154 to the Stonnington Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Stonnington Council as planning authority to prepare the Amendment.

The land affected by the Amendment is the Chadstone Shopping Centre (land at 1341 Dandenong Road, Malvern East) and the land at 2–4 Chadstone Road, Malvern East.

The Amendment proposes to:

- modify the schedule to the Business 1 Zone to increase the maximum combined leasable floor area for shop at Chadstone Shopping Centre from 146,000 sq.m to 160,000 sq.m and delete the reference to minimum of 10,000 sq.m of restricted retail floorspace;
- rezone 2–4 Chadstone Road, Malvern East to Business 1 Zone; extend the Incorporated Plan Overlay Schedule 2 to include land at 2–4 Chadstone Road, Malvern East;

- update Clause 22.11 Chadstone Commercial Centre Policy to clarify the discretion the Responsible Authority has to consider the extent of display and written notice of the display of an application that is generally in accordance with the Incorporated Plan. Delete reference to the Public Transport Corporation and replace it with the Public Transport Division of the Department of Transport at Clause 22.11-3;
- amend Schedule 2 to the IPO (including to replace the existing Chadstone Shopping Centre Incorporated Plan June 2005 with Chadstone Shopping Centre Incorporated Plan September 2011), amend subclause 2.0 to delete reference to the maximum leasable floor area for shop and delete the requirement for closure of the Chadstone Road entrance. Amend the car parking rates specified under Subclause 3.0 of the schedule, delete all Chadstone Road curfew requirements specified under section 3.0 of the schedule and delete all infrastructure requirements specified works section 3.0 of the schedule); and
