VICTORIA PLANNING PROVISIONS
Notice of Approval of Amendment
Amendment VC88

The Minister for Planning has approved Amendment VC88 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by:

- Changing the definition of restricted retail premises to:
 - Include outdoor and recreation goods; animal supplies and pet goods; homewares; baby and children's goods, children's play equipment and accessories; and sporting, cycling, leisure, fitness goods and accessories.
 - Allow goods and accessories which require a large area for handling, display and storage or require direct vehicle access.
 - Clarify that the selling or hiring of goods does not include the sale of food, clothing and footwear unless ancillary to the primary use.
- Changing the Industrial 1, Industrial 3, Business 3, Business 4 zones to remove the floor space restrictions related to Restricted Retail Premises.
