ORDER REVOKING AND APPOINTING PERSONS OR BODIES TO BE WATERWAY MANAGERS IN RESPECT OF SPECIFIED STATE WATERS

I, Dr Denis Naphthine, Minister for Ports make the following Orders.

Pursuant to section 3(3A) of the **Marine Act 1988** I hereby revoke the appointment of the persons or bodies listed in Column 1 of Table 1 to be a waterway manager in respect of the State waters specified opposite the name of the waterway manager in Column 2 of Table 1.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation Rod Newnham, Regional Manager – West, Parks Victoria (Waterway Manager for Port Campbell Bay and the Local Port of Port Campbell), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 10.30 am to 12.15 pm on Sunday 22 January 2012, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Port Campbell Twelve Apostles Plunge open water swim event, is prohibited on the waters of Port Campbell Bay and the Local Port of Port Campbell from the beach to 800 metres seaward; and
2. at the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 152 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
