SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager, Bays and Maritime Operations, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 9.30 pm to 10.30 pm Saturday 28 January 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the Chinese New Year fireworks event and vessels owned and operated by Parks Victoria, are prohibited on the waters of the Yarra River between the downstream edge of Kings Bridge to the upstream edge of Queens Bridge; and
2. at the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

SECTION 15 NOTICE

I, Peter Corcoran, Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Darren Schultz, Building and Contracts Officer, Loddon Shire Council (Waterway Manager for Loddon River at Bridgewater between Flour Mill Weir and Sweeneys Lane), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 8.00 am Friday 27 January 2012 to 8.00 pm on Sunday 29 January 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels and bathers associated with the 2012 Australian Masters Ski Tournament, is prohibited on the waters of Loddon River at Bridgewater between the Calder Highway bridge and Sweeneys Lane;
2. vessels associated with the Bridgewater Water Ski Tournament at Lake Charm are excluded from the provisions of clause 2 (5 knot speed restriction zones) of Schedule 62 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event; and
3. at the completion of the event or at a time determined by Loddon Shire Council to enable the completion of the event, the waters will revert to the provisions of Schedule 62 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

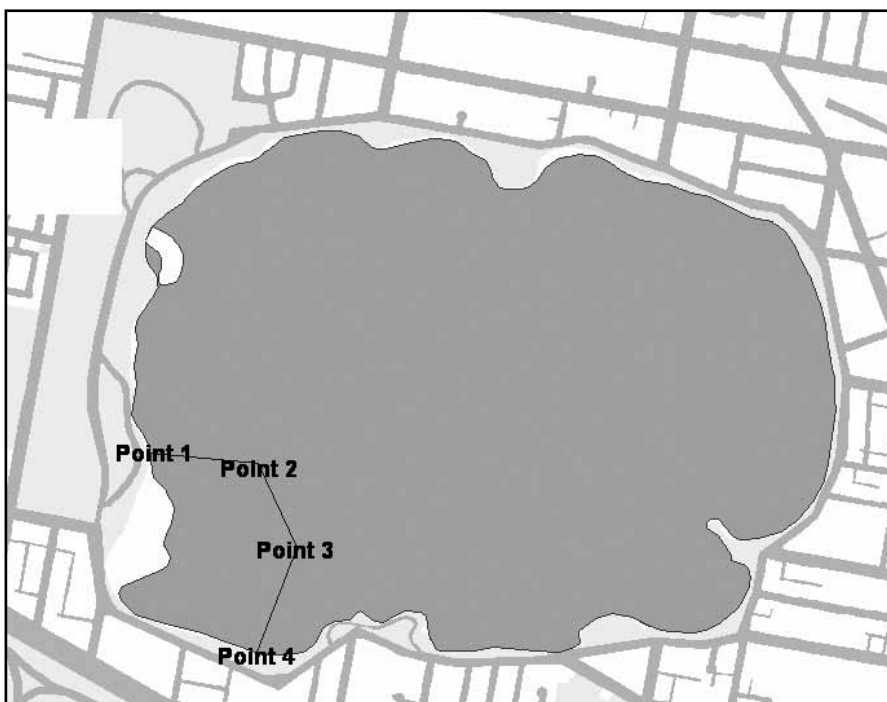

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Bernard Blood, Curator Lake Wendouree, City of Ballarat (Waterway Manager for Lake Wendouree), hereby give notice under section 15(1) of the **Marine Act 1988** that:

- From 2.00 pm Thursday 26 January 2012 to 12.00 am Friday 27 January 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels owned and operated by City of Ballarat, are prohibited on the waters of Lake Wendouree in the south western corner, bounded by the points below and indicated in the diagram.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager Operations, Bays and Maritime, Parks Victoria (the Waterway Manager for the Local Port Of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 9.30 pm to 10.00 pm Saturday 10 March 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels owned and operated by Parks Victoria and Parks Victoria staff, is prohibited within 55 metres radius seaward from a point on the shore approximately 150 metres west of the Altona Pier; and
2. at the completion of the events or at a time determined by Parks Victoria to enable the completion of the events, the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
