## SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager Operations, Bays and Maritime, Parks Victoria (the Waterway Manager for the Local Port Of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 8.30 pm till 10.30 pm Thursday 26 January 2012 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria, is prohibited within a 90 metre radius of a fireworks barge located approximately 250 metres east of the Mornington Pier head;
2. from 8.30 pm till 10.30 pm Thursday 26 January 2012 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria, is prohibited within a 200 metre radius of a fireworks discharge point located approximately 100 metres shoreward of the Rye Pier head; and
3. at the completion of the events or at a time determined by Parks Victoria to enable the completion of the events, the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager, Bays and Maritime Operations, Parks Victoria (Waterway Manager for the Local Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 8.00 pm to 11.30 pm Thursday 26 January 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Festival of Sails Fireworks Event and vessels owned and operated by Parks Victoria, are prohibited within 200 metres of the fireworks barge located on Corio Bay approximately 300 metres north of the Royal Geelong Yacht Club marina; and

**SPECIAL**

2. at the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

**SECTION 15 NOTICE**

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Glenn Santos, Deputy Harbour Master, Port of Melbourne Corporation (port management body for the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that from 10.00 am to 11.59 pm, Saturday 28 January 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding the TS Enterprize, vessels associated with the Princes Pier Fireworks Event and vessels owned and operated by Port of Melbourne Corporation, are prohibited on the waters of Port Phillip Bay east of Princes Pier, within the area detailed below in Table 1.

**Table 1: Princes Pier Exclusion Zone**

The waters bounded by:

- (i) A line extending from a point 37.841945 S, 144.926898 E to a point 37.842317 S, 144.929012 E;
- (ii) A line extending from a point 37.842317 S, 144.929012 E to a point 37.844647 S, 144.928175 E;
- (iii) A line extending from a point 37.844647 S, 144.928175 E to a point 37.844486 S, 144.926008 E; and
- (iv) A line extending from a point 37.844486 S, 144.926008 E to a point 37.841945 S, 144.926898 E.
