NOTICE UNDER SECTION 207(2)

Pursuant to section 207(2) of the **Transport Integration Act 2010** and section 13 of the **Interpretation of Legislation Act 1984**, I fix 1 January 2012 as the relevant date for the purposes of an allocation statement dated on or around the same date as this notice made under section 208 of the **Transport Integration Act 2010** to transfer certain property, rights and liabilities of the Port of Melbourne Corporation existing in or relating to the port of Hastings to the Port of Hastings Development Authority (but excluding property, rights and liabilities existing in or relating to port of Hastings waters).
