## Road Safety Act 1986

### NOTICE UNDER SECTION 92(3)(hb)

#### 1. Purpose

Section 92 of the **Road Safety Act 1986** ('the Act') regulates the use and disclosure of personal information held by the Roads Corporation. Section 92(2) provides that it is an offence for the Roads Corporation to use or disclose personal information except for certain specified purposes.

Section 92(3)(hb) provides an exemption to this offence where the Roads Corporation, or a delegate or employee, discloses personal information to a government department or government agency specified by the Minister by notice published in the Government Gazette. The exemption only applies if the disclosure is for the purpose of assisting with the verification of information in a Victorian driver licence or learner permit that has been produced as evidence of identity to the specified government department or agency.

The purpose of this notice is to specify the government departments and agencies to whom the Roads Corporation may disclose driver licensing information for the purpose of the exemption under section 92(3)(hb).

#### 2. Authorising provision

This notice is made under section 92(3)(hb) of the **Road Safety Act 1986**.

#### 3. Commencement

This notice comes into operation on the date it is published in the Government Gazette.

#### 4. Revocation

The notice published in Government Gazette No. S 212 on 30 June 2011 entitled 'Notice under section 92(3)(hb)' is revoked.

#### 5. Specification

I, Terry Mulder, Minister for Roads, and Minister responsible for administering the Act, specify the following government departments and agencies for the purposes of section 92(3)(hb) of the Act.
