Crown Land (Reserves) Act 1978

ORDER GIVING APPROVAL TO GRANT OF A LICENCE UNDER SECTIONS 17B AND 17DA

Under sections 17B and 17DA of the **Crown Land (Reserves) Act 1978** I, Ryan Smith MP, Minister for Environment and Climate Change, being satisfied that there are special reasons which make the granting of a licence reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a licence to Aquagen Technologies Pty Ltd by the Great Ocean Road Coast Committee Incorporated as the Committee of Management, for a term of nineteen (19) months for the purpose of 'Energy Production' over the area of Crown land being part of the Lorne Pier Reserve described in the Schedule below and, in accordance with section 17B(3)(a) of the **Crown Land (Reserves) Act 1978**, state that –

- (a) there are special reasons which make granting the licence reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

The area indicated by yellow border on the plan labelled 'LORNE PIER – LP/3.10.2012' attached to Department of Sustainability and Environment file No. 0513459 being part of Allotment 16, Section 5, Township and Parish of Lorne, being Crown land permanently reserved for the purpose of Protection of the Coastline by Order in Council of 8 November 1983 and by Notice published in the Government Gazette of 16 November 1983, page 3706.
