I, Peter Walsh, Minister for Water, in accordance with the **Water Act 1989** and the **Interpretation** of Legislation Act 1984, make the following Instrument.

1. Preliminary

The Appointment of Grampians Wimmera Mallee Water Corporation as Storage Manager for the Wimmera–Mallee System Headworks (the Instrument of Appointment) was made by the then Minister for Water on 26 October 2010 to appoint Grampians Wimmera Mallee Water Corporation as storage manager in respect of the bulk entitlements and environmental entitlements granted for the Wimmera–Mallee system headworks.

2. Purpose

This amendment Instrument has two purposes: 1) to ensure the instrument is consistent with the current provisions of the **Water Act 1989** and 2) to correct errors made in the drafting of the entitlement instruments.

3. Empowering Provisions

This instrument is made in accordance with section 122ZK of the Water Act 1989 and section 41A of the Interpretation of Legislation Act 1984.
