## Food Act 1984

### EXEMPTION FOR RETAIL AND CATERING

I, Pradeep Philip, Secretary of the Department of Health under section 5(5) of the **Food Act 1984** by order exempt all persons to whom the requirements in clause 3 of Standard 2.2.2 apply from complying with those requirements as follows:

- (a) in the case of eggs from chickens for retail sale or for catering purposes – until 25 November 2014;
- (b) in the case of all other eggs for retail sale or for catering purposes – while this order is in force.

#### Definitions

In this order –

**catering purposes** has the same meaning as in Standard 2.2.2;

**egg** has the same meaning as in Standard 4.2.5, Primary Production and Processing Standard for Eggs and Egg Product contained in Chapter 4 of the Food Standards Code;

**retail sale** has the same meaning as in Standard 2.2.2;

**Standard 2.2.2** means Standard 2.2.2 of the Food Standards Code.

#### Commencement

This order takes effect on 26 November 2012.

**Food Act 1984**

EXEMPTION FROM PART VI FOR EGG PRODUCTION PREMISES

I, Pauline Ireland, as a delegate of the Minister for Health under section 5(3A)(a) of the **Food Act 1984** order that –

1. a food premises at which eggs are produced is exempt from all of the provisions of Part VI of the Act if the only activities at that premises that involve the operation of a food business are any of the following:
  - (a) the grading, packing, washing, oiling, candling or assessing for cracks, of eggs; or
  - (b) pulping eggs for supply to an egg processor; or
  - (c) the storing or transporting of eggs or egg pulp; or
  - (d) the sale of eggs directly to the public –including when any of these eggs, or eggs that are pulped at the food premises, were produced at any other premises; and
2. in this order –
  - egg** has the same meaning as in Standard 4.2.5;
  - egg processor** has the same meaning as in Standard 4.2.5;
  - egg pulp** has the same meaning as in Standard 4.2.5;
  - produced** means the collection of eggs from birds kept on a site;
  - Standard 4.2.5** means Standard 4.2.5, Primary Production and Processing Standard for Eggs and Egg Product contained in Chapter 4 of the Food Standards Code.

**Commencement**

This order takes effect on 26 November 2012.
