ORDER EXEMPTING PERSONS FROM PRIMARY PRODUCTION AND PROCESSING REQUIREMENTS OF THE FOOD STANDARDS CODE

I, Jeff Rosewarne, Secretary of the Department of Primary Industries, acting under section 5(5) of the **Food Act 1984** (the Act), exempt the class of persons listed in Column 1 of the Table below from the requirements of the Food Standards Code specified in Column 2 of the Table, subject to the condition or in the circumstance specified in Column 3 of the table (if any), that corresponds to the item number specified in the Table.

The exemption granted to the class of persons listed in Column 1 of the Table below is granted and continues in operation until the period described in Column 4 of the Table that corresponds to the item number specified in the Table, unless earlier revoked.

A reference in this Order to Standard 4.2.5 is a reference to Standard 4.2.5, 'Primary Production and Processing Standard for Eggs and Egg Product', of the Food Standards Code.

Clause 13(3) of Standard 4.2.5	The exemption from clause 13(3) of Standard 4.2.5 is subject to the conditions that – (i) the egg processor operates according to a Food Safety Management Statement that sets out how the requirements of Division 3 of Standard 4.2.5 are to be or are being complied with; and (ii) the Food Safety Management Statement a. has been approved or recognised by the Secretary of the Department of Primary Industries; and b. is subject to ongoing verification activities by the producer; and c. if required by the Secretary of the Department of Primary Industries, is also subject to ongoing verification activities by the Department of Primary.
