PUBLIC NOTICE

Declaration of Boating Activity Exemption

I, Peter Brown, as delegate of the Horsham Rural City Council, the waterway manager for the Wimmera River (within the boundaries of Horsham Rural City), declare under section 203(3) of the **Marine Safety Act 2010** that the Kannamaroo Festival Water Skiing Exhibition event proposed by Natimuk Lake Water Ski Club on 24 November 2012 is exempt from:

1. The requirements to operate a vessel at a speed not exceeding 5 knots within 50 metres of the water's edge as detailed in clause 3(a) of the Notice under section 15(2) of the **Marine Act 1988**;
2. The requirements of clauses 69.1 and 69.3 of Schedule 69 made under section 15(2) of the **Marine Act 1988** in relation to the 5 knot speed restriction zone and no wash zone.

The exemptions apply to persons and vessels participating in the Kannamaroo Festival Water Skiing Exhibition from 10.00 am to 4.00 pm on Saturday 24 November 2012 on the waters of the Wimmera River at Horsham between the Apex Park Island and the Western Highway Bridge.

NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

I, Peter Brown, as delegate of the Horsham Rural City Council, the waterway manager for the Wimmera River (within the boundaries of Horsham Rural City), hereby give notice under section 208(2) of the **Marine Safety Act 2010** that all persons and vessels not participating in the Natimuk Lake Water Ski Club, Kannamaroo Festival Water Skiing Exhibition from 10.00 am to 4.00 pm on Saturday 24 November 2012 are prohibited from entering and remaining in the waters of the Wimmera River at Horsham between the Apex Park Island and the Western Highway Bridge.

The exclusion zone takes effect between 10.00 am and 4.00 pm on 24 November 2012.
