Local Government Act 1989 REVOCATION OF TOW AWAY AREAS

1. Purpose

The purpose of this instrument is to revoke tow away areas located on La Trobe Street, Melbourne.

2. Commencement

This instrument takes effect at 12.01 am on Thursday 13 December 2012.

3. Authorising Provisions

Clause 4 of Schedule 11 to the **Local Government Act 1989** provides that a municipal council may move or impound any vehicle that is causing an unlawful obstruction, or that is unlawfully parked or left standing in an area designated by the Minister (referred to in this instrument as a 'tow away area') and may charge the owner of the vehicle a fee up to the amount of the fee set for the purposes of clause 3(1)(c).

Section 27 of the **Interpretation of Legislation Act 1984** provides that where an Act confers power to make a subordinate instrument the power shall, unless the contrary intention expressly appears, be construed as including a power, exercisable in the same manner and subject to the same conditions or limitations (if any), to repeal or amend a subordinate instrument made in the exercise of that power.

4. Revocation

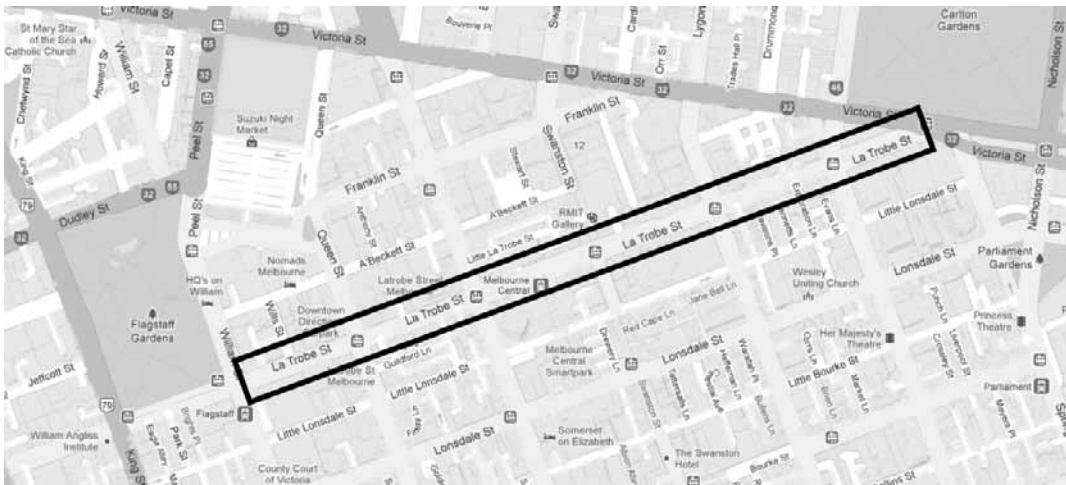
