SCHEDULE 11, CLAUSE 4

Designation of Tow Away Area in the Chapel Street Precinct

Clause 4 of Schedule 11 to the **Local Government Act 1989** provides that a municipal council may move or impound any vehicle that is causing an unlawful obstruction, or that is unlawfully parked or left standing in an area designated by the Minister (referred to in this instrument as a 'tow away area'), and may charge the owner of the vehicle a fee up to the amount of the fee set for the purposes of clause 3(1)(c) of Schedule 11 to the **Local Government Act 1989**.

For the purpose of these provisions, I, Terry Mulder, Minister for Roads, designate the taxi zones along or in the vicinity of Chapel Street, City of Stonnington, as shown in the Schedule, to be tow away areas from 11 pm Friday until 5 am Saturday and from 11 pm Saturday until 5 am Sunday each week.

This instrument takes effect on the day it is published in the Victoria Government Gazette.

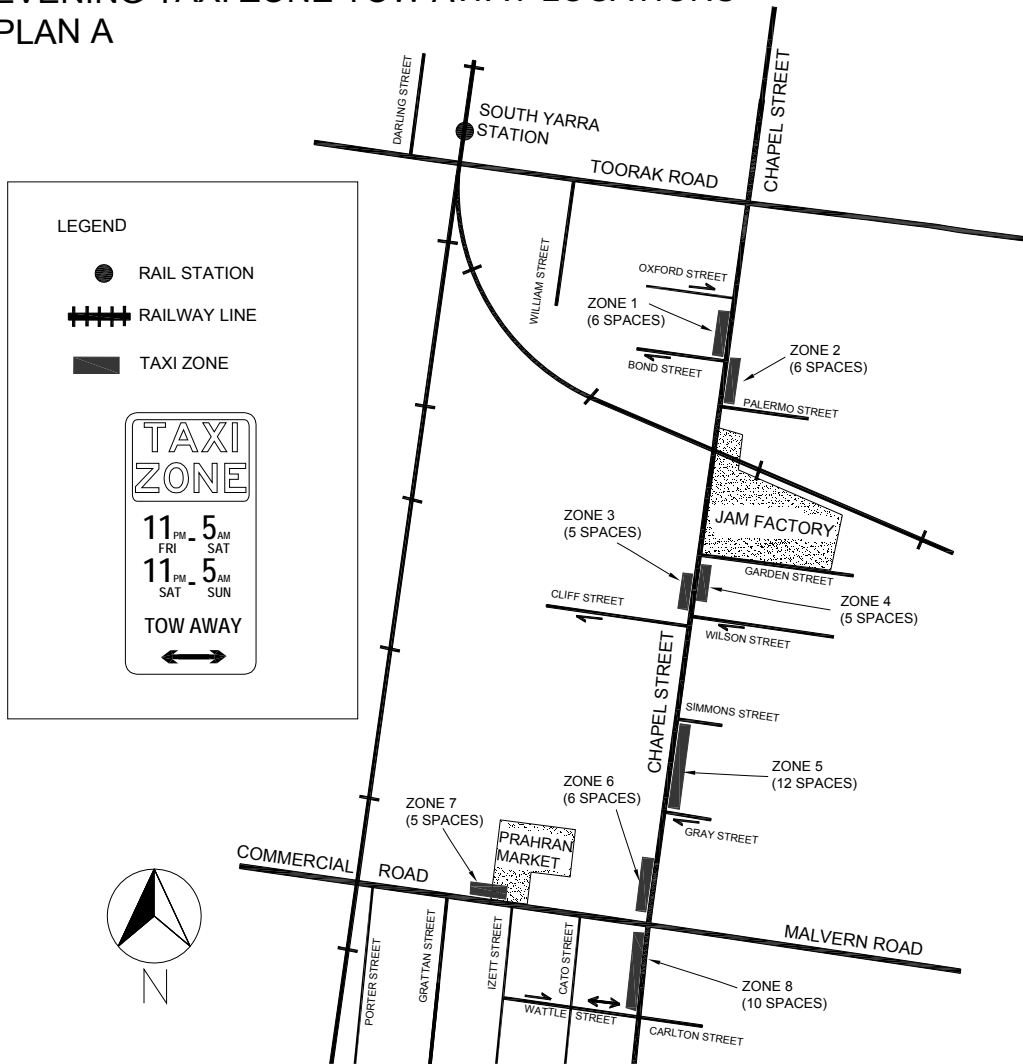

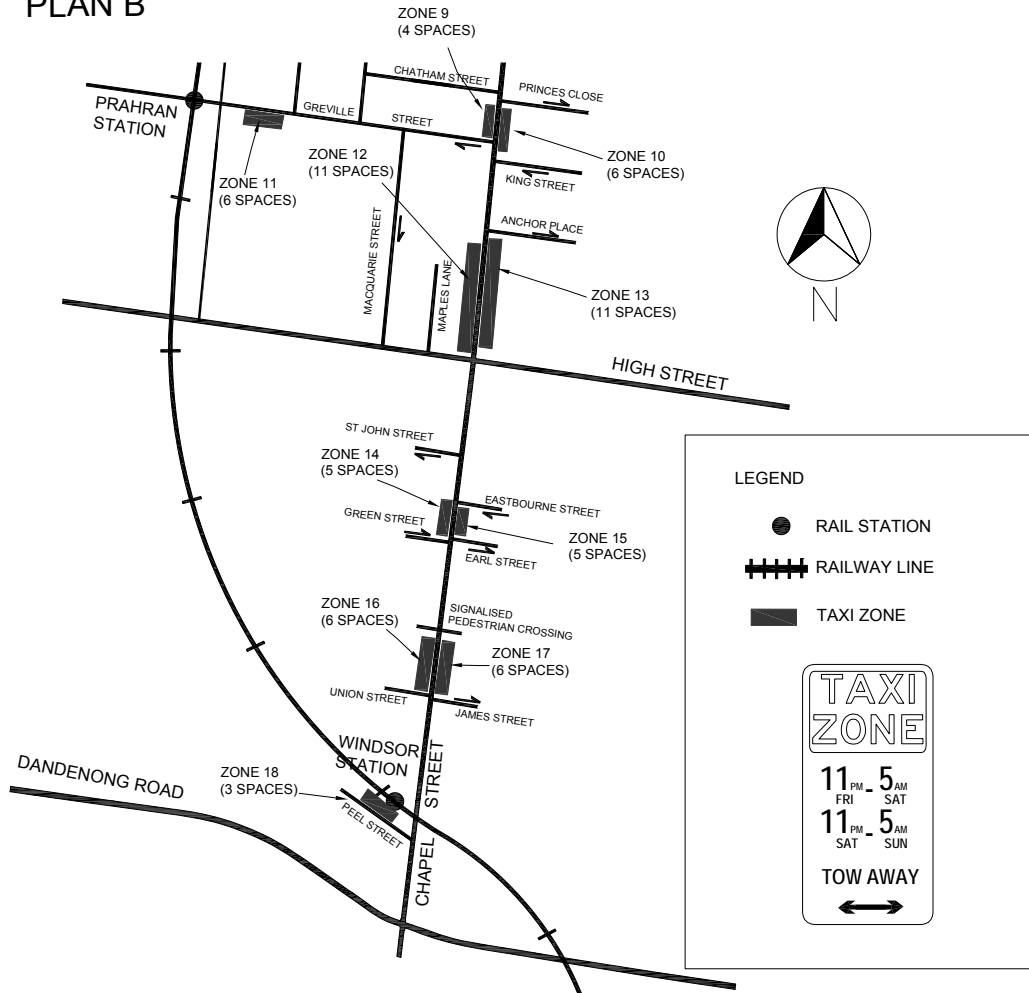
