- 78/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If a provision of this Act does not come into operation before 1 July 2013, it comes into operation on that day.
- 79/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If a provision of this Act does not come into operation before 1 April 2013, it comes into operation on that day.
- 80/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If a provision of this Act does not come into operation before 1 November 2013, it comes into operation on that day.
- 81/2012 (1) This Act, other than sections 113(2) and 115(2), comes into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Sections 113(2) and 115(2) come into operation on 30 December 2014.
- 82/2012 (1) This Part and Divisions 2 and 3 of Part 5 come into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Section 153 is taken to have come into operation on 6 March 2012.  
(3) Section 154 is taken to have come into operation on 18 September 2012.  
(4) The remaining provisions of this Act, other than Part 8, come into operation on a day or days to be proclaimed.

**SPECIAL**

- (5) Part 8 comes into operation on the day after the day on which the last provision of this Act (other than Part 8) comes into operation.
- 83/2012
- (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
  - (2) If a provision of this Act does not come into operation before 1 July 2013, it comes into operation on that day.
- 84/2012
- (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
  - (2) If a provision of this Act does not come into operation before 1 June 2013, it comes into operation on that day.
- 85/2012
- (1) This Act comes into operation on a day or days to be proclaimed.
- 86/2012
- (1) Subject to subsection (2), this Act comes into operation on a day to be proclaimed.
  - (2) If this Act does not come into operation before 1 March 2013, it comes into operation on that day.
