- 72/2012 (1) This Act (except Part 2) comes into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Part 2 comes into operation on 1 January 2013.
- 73/2012 (1) This Part and Part 7 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 January 2013, it comes into operation on that day.
- 74/2012 (1) This Act comes into operation on 1 January 2013.
- 75/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 July 2014, it comes into operation on that day.
- 76/2012 (1) This Act (except Part 3) comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Subject to subsection (3), Part 3 comes into operation on a day to be proclaimed.
- (3) If Part 3 does not come into operation before 30 March 2013, it comes into operation on that day.
