REVOCATION OF THE PROCLAMATION OF THE APPROVED MENTAL HEALTH SERVICE KNOWN AS 'NORTH EAST PSYCHIATRIC SERVICES' AND PROCLAMATION OF AN APPROVED MENTAL HEALTH SERVICE KNOWN AS 'NORTHEAST AND BORDER MENTAL HEALTH SERVICE'

I, Alex Chernov, Governor of Victoria, with the advice of the Executive Council and under section 94(1) of the **Mental Health Act 1986** ('the Act') fix 10 December 2012 as the day on which –

- (a) the proclamation made by the Governor in Council under section 94(1) of the Act on 21 April 1998 and published in the Government Gazette S33 on 22 April 1998, which proclaimed Wangaratta District Base Hospital, situated at Green Street Wangaratta, to be an approved mental health service known as 'North East Psychiatric Services', is revoked; and
- (b) Northeast Health Wangaratta, situated at Green Street Wangaratta, is proclaimed to be an approved mental health service known as 'Northeast and Border Mental Health Service'.

ALLOCATION OF PROPERTY RIGHTS AND LIABILITIES OF BEECHWORTH HEALTH SERVICE AND NORTHEAST HEALTH WANGARATTA TO ALBURY WODONGA HEALTH

Order in Council

The Governor in Council, on the recommendation of the Minister for Health made under section 248 of the **Health Services Act 1988** ('the Act') and acting under section 248(1)(d) of the Act by this Order –

- 1. Allocates such of the property, rights and liabilities of Beechworth Health Service to Albury Wodonga Health as specified in the sub-clauses below:
 - 1.1 all property, rights and liabilities in respect of the motor vehicle described in item 1 of Schedule 1 to this Order;
 - 1.2 all property, rights and liabilities in respect of the plant and equipment described in item 2 of Schedule 1 to this Order;
 - 1.3 all property, rights and liabilities in respect of the residential agreements between Beechworth Health Service and individual high care residents of Blackwood Cottage; and
 - 1.4 all property, rights and liabilities in respect of:
 - (a) all medical records and medical files in whatever format that relate to the treatment of mental health patients at the Beechworth Health Service; and
 - (b) all other records and files in whatever format that relate to the treatment of mental health patients at the Beechworth Health Service.

- 2. Allocates such of the property, rights and liabilities of Northeast Health Wangaratta to Albury Wodonga Health as specified in the sub-clauses below:
 - all property, rights and liabilities in respect of the motor vehicles described in item 1 of Schedule 2 to this Order;
 - all property, rights and liabilities in respect of the plant and equipment described in item 2 of Schedule 2 to this Order;
 - 2.3 all property, rights and liabilities in respect of the agreements described in item 3 of Schedule 2 to this Order; and
 - 2.4 all property, rights and liabilities in respect of:
 - (a) all medical records and medical files in whatever format that relate to the treatment of mental health patients at Northeast Health Wangaratta; and
 - (b) all other records and files in whatever format that relate to the treatment of mental health patients at Northeast Health Wangaratta.

DEFINITIONS AND INTERPRETATION

- 3. In this Order and Schedules 1 and 2:
 - (a) the terms 'property', 'rights' and 'liabilities' have the meaning given to them by section 244 of the Act;
 - (b) the term 'Blackwood Cottage' means the campus of Beechworth Health Service located at 52 Sydney Road Beechworth.
 - (c) the term 'Green Street' means the campus of Northeast Health Wangaratta located at 35–47 Green Street Wangaratta.
 - (d) the term 'Kerferd Unit' means the campus of Northeast Health Wangaratta located at 35–47 Green Street Wangaratta.
 - (e) the term 'Mackie House' means the campus of Northeast Health Wangaratta located at 82a Murdoch Road Wangaratta.
 - (f) the term 'Rivers' Edge' means the campus of Albury Wodonga Health located at 66–68 Faithful Street Wangaratta.
 - (g) the term 'the Willows' means the campus of Beechworth Health Service located at 8, 9, 10 and 11 Mayday Court Beechworth and 9, 11 and 13 Gilchrist Avenue Beechworth.
 - (h) a reference to each of the Beechworth Health Service and Northeast Health Wangaratta is a reference to a public hospital within the meaning of section 3 of the Act.
 - (i) a reference to Albury Wodonga Health is a reference to a public health service within the meaning of section 3 of the Act.
