Road Management Act 2004 ROAD DECLARATIONS

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes or declares the roads described in Schedule A and on the plans attached. The effects of these revocations and declarations on road names are described in Table 1. VicRoads also authorises the access point described in Schedule B and on the plan attached.

SCHEDULE A

FREEWAY

a) Those parts of Princes Freeway identified by hatching on the plans numbered GP22308 and GP22310 are revoked or declared as described in the legend in the said plans.

ARTERIAL ROAD

- b) Those parts of Truganina–Seabrook Road identified by hatching on the plans numbered GP22308A, GP22311, GP22312, GP22313, GP22314, GP20897, GP22247 and GP22246 are declared as described in the legend in the said plans.
- c) That part of Point Cook Road identified by hatching on the plan numbered GP22246 is declared as described in the legend in the said plan.
- d) Those parts of Braeside–Dandenong Road identified by hatching on the plan numbered GP22499 are declared as described in the legend in the said plan.
- e) Those parts of Breakwater Road identified by hatching on the plans numbered GP20469 and GP20912 are declared as described in the legend in the said plans.
- f) Those parts of Barwon Heads Road identified by hatching on the plans numbered GP20912 and GP10054 are declared as described in the legend in the said plans.
- g) Those parts of Condah–Coleraine Road identified by heavy solid line on the plans numbered GP280AR and GP281AR are declared as described in the legend in the said plans.
- h) That part of Mt Duneed Road identified by heavy solid line on the plan numbered GP279AR is declared as described in the legend in the said plan.
- i) That part of Morwell–Thorpdale Road identified by hatching on the plan numbered GP21921 is declared as described in the legend in the said plan.


- 1. Names in Columns 1 and 2 are not affected by this declaration, unless otherwise noted.

- 4. Column 1 and 2 details are for general information purposes only.


