NOTICE OF GUIDELINES ISSUED UNDER SECTIONS 15(1BB) AND 120A FOR THE DESCRIPTION OF A MINERAL RESOURCE IN A MINING LICENCE OR RETENTION LICENCE APPLICATION

I, Michael O'Brien, Minister for Energy and Resources, and Minister responsible for administering the **Mineral Resources (Sustainable Development) Act 1990**, in accordance with sections 15(1BB) and 120A of the **Mineral Resources (Sustainable Development) Act 1990** hereby give notice of guidelines I have issued for the purposes of describing a mineral resource in an application for a retention licence or a mining licence (not including an infrastructure mining licence) ('the guidelines').

The guidelines must be read in conjunction with other licence application requirements in the **Mineral Resources (Sustainable Development) Act 1990** and the Mineral Resources Development Regulations 2002.

The guidelines take effect on the date that this notice of the making of the guidelines is published in the Victorian Government Gazette.
