## Road Safety Act 1986

### DECLARATION UNDER SECTION 99B(4)

Acting under Sections 99B(4) a of the **Road Safety Act 1986**, I declare that for the purposes of filming a TAC commercial that the provisions of the Road Safety (Vehicles) Regulations 2009 specified in the Schedule do not apply to the activities of the Event for the Periods specified in the Schedule.

1. In this notice, unless the context or subject matter otherwise requires –  
**‘Event’** means the TAC commercial to be produced by Revolver Films, on the Highways and during the Periods specified in the Schedule;
2. This declaration takes effect from the date of commencement of the Event until completion of the Event.

#### EXEMPT PROVISIONS OF ROAD SAFETY (VEHICLES) REGULATIONS

- Section 14 (Eligible Vehicles);
- Section 249 (Towing Offences);
- Section 258 (Use of Vehicles Not Complying With Standards); and
- Section 259 (Other use of Vehicle Offences).

#### HIGHWAYS SUBJECT TO THIS DECLARATION AS PART OF THE EVENT

- Fenton Street, Huntingdale, from north of North Road to south of Hargreaves Street
- Stafford Street, Huntingdale, from Fenton Street to approximately 120 metres west of Fenton Street.
