NOTICE OF DECISION

Accident Compensation Regulations 2012

I, Gordon Rich-Phillips, Assistant Treasurer and Minister responsible for administering the **Accident Compensation Act 1985** and the **Accident Compensation (WorkCover Insurance) Act 1993**, give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to make the proposed Accident Compensation Regulations 2012 (the proposed Regulations).

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Regulations. The objectives of these Regulations are to prescribe:

- amounts not to be taken as remuneration for certain classes of contractors;
- the formula for calculating contributions payable to the Authority by self-insurers; and
- certain other matters and things required or permitted to be prescribed or necessary to be prescribed to give effect to the **Accident Compensation Act 1985** and the **Accident Compensation (WorkCover Insurance) Act 1993**.

The RIS was advertised in the Victoria Government Gazette and The Age seeking public comment. The public comment period started on 28 November 2011 and ended on 9 January 2012. Written submissions in response to the RIS were received and considered.

After consideration of the submissions received, I have decided that the proposed Regulations should be made with no amendments.
