SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager, Bays and Maritime Operations, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. The operation of vessels (including anchoring, mooring or allowing a vessel to lie), is prohibited on the waters of the Yarra River at the times specified in Table 1 and within the areas detailed in Table 2, excluding vessels associated with the events listed in Table 1, vessels owned and operated by Parks Victoria, and vessels authorised by Parks Victoria at such times as determined by Parks Victoria.
2. At the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Steve Crawcour, Chief Executive Officer, Shire of Strathbogie (the Waterway Manager for the Goulburn River between Hughes Creek and the Goulburn Weir including the waters of Lake Nagambie), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 11.00 am to 4.00 pm on Saturday 3 March 2012, the operation of vessels (including anchoring, mooring or allowing a vessel to lie) excluding:
 - (a) vessels involved in the NOW Festival events; and
 - (b) vessels operated by Strathbogie Shire Council; and
 - (c) vessels travelling to and from 'The Jetty' accommodation units travelling at 5 knots and within 15 metres of the shoreline excluding during the swim event;is prohibited on the waters of Lake Nagambie extending:
 - (a) south and east of an imaginary line commencing at Huttons Point; and
 - (b) westerly to the 500 m mark of the rowing course located within the 'un-powered boating zone' described in Item 14 of Schedule 91 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**; and
 - (c) southerly to the shore.
2. Vessels and persons involved in the NOW Festival events are excluded from the requirements of Clauses 10(a), 11 and 14 of Schedule 91 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event.
3. At the completion of the event or at a time determined by the Shire of Strathbogie to enable the completion of the event, the waters will revert to the provisions of Schedule 91 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Helen Papagiannis, Event Entertainment Manager, Parks Victoria (Waterway Manager for Albert Park Lake), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. The operation of vessels (including anchoring, mooring or allowing a vessel to lie), is prohibited on the waters of Albert Park Lake for the dates and times specified in Table 1.
2. Parks Victoria vessels and vessels approved by Parks Victoria are excluded from the prohibition on the operation of vessels for the times detailed in Table 1.
3. Parks Victoria vessels and vessels approved by Parks Victoria are excluded from the provisions of Clause 1 (5 knot speed restriction) of Schedule 151 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the times listed in Table 1.
4. Vessels involved with the Australian Grand Prix 'Lake Activity' water ski show are excluded from clauses 2(a), 2(c), 3(a), 3(b), 14, and 19(b) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the times listed in Table 1.
5. Skiers involved in the water ski trick ski events are exempt from the requirements of Regulation 234(1) of the Marine Regulations 1999 and Clause 19(d) of Notice No. 1 under section 15(2) of the **Marine Act 1988**, for the times listed in Table 1.
6. At the completion of events on any of the days detailed in Table 1 or at a time determined by Parks Victoria to enable the completion of events, the waters will revert to the provisions of Schedule 151 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
