Marine Act 1988

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of David Jackson, Manager Land and On Water, Goulburn Murray Water (Waterway Manager for Lake Hume), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 8.00 am to 6.00 pm on Saturday 24 March 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Hume Boat Club (HBC), Club Day racing event and vessels approved by Goulburn Murray Water, is prohibited on the waters of Lake Hume in an area marked by buoys in the vicinity of the HBC leasehold upstream of the Bethanga Bridge, Bellbridge;
2. Vessels competing in the HBC Club Day racing event at Lake Hume are excluded from the requirements of Clauses 2(c) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event;
3. Vessels competing in the HBC Club Day racing event at Lake Hume are exempt from the requirements of Regulation 228(3) and 229 of the Marine Regulations 1999, in respect to the requirement to carry a torch, bailer, fire extinguisher, navigation lights, paddles and bucket for the duration of the event; and
4. At the completion of the event or at a time determined by Goulburn Murray Water to enable the completion of the event, the waters will revert to the provisions of Schedule 95 contained in Notice No.1 under section 15(2) of the **Marine Act 1988**.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Geoffrey Rollinson, Director, Infrastructure Planning and Regulatory Services, Gannawarra Shire Council (Waterway Manager for Lake Charm), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. Between the hours of 7.00 am and 7.00 pm on Sunday 18 March 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels and bathers associated with the Victorian Outboard Club Point Score Event, is prohibited on all of the waters of Lake Charm;
2. Vessels associated with the Victorian Outboard Club Point Score Event at Lake Charm are excluded from the provisions of Schedule 139 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event;

SPECIAL

3. Vessels competing in the Victorian Outboard Club Point Score Event at Lake Charm are excluded from the requirements of Clauses 2(a), 2(c) and 3(b) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event;
4. At the completion of the event or at a time determined by Gannawarra Shire Council to enable the completion of the event, the waters will revert to the provisions of Schedule 139 contained in Notice No.1 under section 15(2) of the **Marine Act 1988**.
